

TERMS AND CONDITIONS OF THE UFO BUFO FESTIVAL
LOCATION: HADINKA (CHKO ODERSKÉ VRCHY) | ORGANIZER: SPOLEK ŽABART

BY ENTERING THE FESTIVAL AREA, CAMPGROUND, OR PARKING LOT, THE VISITOR ENTERS INTO AN AGREEMENT WITH THE ORGANIZER REGARDING PARTICIPATION IN A CULTURAL EVENT. ENTRY CONSTITUTES ACCEPTANCE OF THESE TERMS AND CONDITIONS, AND THE VISITOR UNDERTAKES TO COMPLY WITH THEM. All activities within the premises are subject to the laws of the Czech Republic.

Art. I - Conditions of Stay and Identification of Participants

- Every visitor is required to present a valid ticket, which will be exchanged for a non-transferable identification wristband.
- Absence of Data Signal:** There is a critical lack of mobile data signal at the location. Visitors must present their electronic ticket (QR code or alphanumeric code). On-site payments are accepted exclusively in cash (CZK/EUR).
- "One-day" Admission and Early Departure:** The possibility of a refund (or financial difference) upon early departure from the festival and return of the identification wristband is strictly governed by the valid festival price list and its specific conditions for refundable daily admission.

Art. II - Strict Prohibition of Animals

- For safety and veterinary reasons, there is an absolute prohibition of entry with dogs or any other animals into all areas of the festival, including tent campgrounds and parking lots.
- Violation of this prohibition entitles the organizer to immediately remove the identification wristband and expel the person from the festival premises without any right to a ticket refund or any other compensation.

Art. III - Parking, Accommodation, and Fire Safety

- Motor vehicle entry into the standard tent campground is prohibited. Entry into the designated Caravan Camp is permitted only with a valid permit until capacity is reached.
- A strict prohibition of open fires applies throughout the entire venue and campgrounds. The use of portable technical grills is permitted exclusively within the campgrounds. Establishing open campfires outside official designated areas is classified as a serious offense.

Art. IV - Hygiene, Sanitation, and Water Bodies Regime

- Visitors are required to maintain cleanliness in all sanitary facilities (mobile toilets, washing troughs) and to prevent the contamination of water sources. The water in the sanitary facilities and at the troughs is potable.
- Pond Regime:** The local pond and adjacent watercourses are intended exclusively for swimming and refreshment (at one's own risk). It is strictly forbidden to perform any personal hygiene (washing body, hair, etc.) in the pond. Festival sanitary facilities (washing troughs, showers) must be used exclusively for washing purposes.
- Due to contamination risks, there is a **strict prohibition on washing any dishes in the stream or in the pond**. The use of conventional chemical shampoos and soaps is prohibited within the venue, especially in water bodies. We recommend using ecologically degradable products in the washrooms.

Art. V - Safety, Health Protection, and Legal Framework

- All activities and behavior within the festival area are subject to the applicable legal framework and laws of the Czech Republic. Any illegal conduct (sale of illicit substances, property crime, physical violence) will be immediately reported to the Police of the Czech Republic.
- Persons under 15 years of age are only permitted entry when accompanied by a legal guardian, who bears full responsibility for them. A medical service and psychological assistance station (PSYCARE) is established on-site. The visitor acknowledges the specific climatic conditions in the valley (night temperatures below 10 °C).

Art. VI - Nature Protection, Sanctions, and Closing Provisions

- The venue is located within the Oderské vrchy Protected Landscape Area (CHKO). Visitors are required to strictly maintain cleanliness and avoid damaging the surrounding flora and fauna.
- Serious non-compliance with these rules constitutes grounds for immediate expulsion from the event and removal of the wristband without compensation. Visitors are obliged to follow the instructions of persons authorized to manage the festival, identified by badges: **Crew, Stage manager, Security, Organizer, Bar staff, or Electrician**.
